03/22 Co-option of new councillor

David Harvey was voted on unanimously as a Parish Councillor and duly signed his declaration Clerk to inform BDC.

04/22 Public Forum

MOP - Request for dog bin on Rowthorne lane.

Clerk to get cost, highways advice and time frame. Potential site, grassed area opposite the old post office.

MOP- Plug and feathers change of application to convenience store. It has been called in to full council meeting and people can contact the council and register to speak. There have been three accidents on the A617 would this have any bearing on change of use. Can we ask for money from developer to go towards road safety. Could there be a bargaining position of if a crossing with lights is placed on The Hill and double yellow lines outside the building it would be viewed more favourably? Would Highways take up this suggestion?

MOP- Is there still a bypass in the planning? Concerns that the vibrations of the increased traffic is having an effect on the houses themselves? It was confirmed that there has been plans for over 50 years but with no bypass as yet built.

County Councillor will request another traffic survey at an appropriate location and time of day.

Regarding Back Lane - Cllr. Barron was reminded of the suggestion put forward to decrease speed and dissuade cars from using it. It was also suggested that if the junction were safer cars would be less likely to use Back Lane. Cllr. Barron will chase this up.

Shirebrook link road no update

Cllr. Barron asked that the care home consultation was promoted and people encouraged to fill it in. Cllr. Clough reported that she attended a zoom meeting and was disappointed that lead cabinet member did not attend. Cllr. Barron reported that Simon Steven attended but he will pass on Cllr. Clough's comments. Consultation closes on 4th March 2022.

06/22/03 District Councillor

Cllr. Clough is hoping to return to duties next week.

Cllr. Kirkham reported that the Plug and Feathers application was called in due to the number of objections. He encouraged people to write in with questions.

Cllr. Kirkham reported that at Full Council Meeting on Wednesday he would be asking questions relating to the sale of land on Park Avenue. This was opposed in a petition of over 1000 signatures and the question is in relation to the manner in which the sale was conducted, including that key documents were not signed when the announcement of sale was made following the winning of the vote. It calls into question BDC behaviour. The response to the Parish Councils open letter calling for the funds to be spent in Glapwell has not elicited any evidence that Glapwell residents will benefit from this money. Glapwell have lost resources from this sale and it is only right to give the money to the parish. If they respond negatively, we can ask to put a motion in at the next full council meeting. If BDC want support against the reorganisation proposed in "Levelling up" they must be seen to support local opinion. It is not unreasonable to ask for the section 106 money up front or the 250k.

Kirkham to approach Chris McKinley and ask if these claims are true and invite him to attend a Parish Council meeting to address these concerns.
