Minutes of meeting of Glapwell Parish Council held on Thursday 26 October 2017 At the Glapwell Centre

100/17 Apologies for Absence –Councillor Clive Moesby, Keith Woollen

101/17 Declarations of Interest – None

102/17 Public Forum

Complaint – A complaint had been received from a resident about unsafe working practices of a contractor working on the roof of the Sports Hall. The complaint had been investigated and a reply received from the contractor. He explained that the main part of the repairs had been carried out the previous day when full safety precautions were in place and that the workman had returned to complete the job. They had been reprimanded and told to ensure that safety regulations were complied with at all times. The Health and Safety Executive had been informed and had agreed that there would not further action taken. The second part of the repairs to the roof had been halted until there had been a discussion at the Parish Council. **It was agreed that 1) the further work could go ahead on condition that safe and appropriate working practices were adhered to and 2) in future works the Council should check that a risk assessment be undertaken before the work was carried out.**

Parking in Layby – John Jepson asked about the legality of a catering business in the lay-by from M1 roundabout to Doe Lea threatening £100 penalty for parked vehicles. **It was agreed to raise the matter with Highways.**

Playground – Rachel Hibbert informed the Council of a complaint about a resident using the playground as an exercise ground for their dog. **It was agreed to check the CCTV cameras for evidence and the refer the matter to the police.**

Leaves on Hall Corner – Jackie Hole reported that there were the usual piles of leaves that needed clearing. **It was agreed to refer the matter to Bolsover District Council.**

Maple Grove Bungalows – David Clough reported that the grass had been cut recently. It was agreed to raise the matter with Bolsover District Council.

Drilling on Back Lane – John Jepson asked for information on the reason for the drilling. Clive Fleetwood said he believed that it was related to the housing development of 5 houses in that area.

103/17 Minutes

Council Meeting held on 28th September 2017

The minutes were agreed as a correct record of the meetings and signed by the chair of the meeting.

104/17 Matters Arising

Footpath on Rowthorne Lane – It was agreed to raise the matter with Councillor Moesby.

Speed Monitors – A report was outstanding on the monitors placed on The Hill by DCC in July.

Dog Bin – The bin had not been replaced yet but a new stake had been erected. However a bill had been received by the Council for the emptying of the bin from July to September. It was agreed to raise the matter with Bolsover District Council.

Christmas Lights – The Christmas lights had been ordered and would be installed on December 1st on 20 lamp posts around the village at a cost of £1900 +vat.

105/17 Reports

Police-There was no report available.

Derbyshire County Council – There was no report available.

Bolsover District Council- Councillor Syrett provided a report on a meeting held on 16th October about traffic issues in the village. The meeting involved officers from DCC Highways, BDC Estates and Housing and the Parish Council. A number of options had been identified including waiving of fees to allow kerbs to be dropped to allow off street parking. The representative from DCC had ruled out the use of double yellow lines to stop people parking on dangerous corners and narrow streets. A report will be produced for further discussion with the Parish Council looking at ways of managing parking more effectively and also alleviating the problems of access because of parked cars. It was agreed that once this report was available it was essential to involve residents in the decisions on any action agreed.

106/17 Glapwell Centre

Roof Repairs – The repairs to the Sports Hall had been carried out,

Damaged Blinds – There had been further damage to the blinds in the Sports Hall. It was agreed to get a quote from the fitter to carry out the repairs and to

compare this to the cost of fitting film on the windows as a more effective way of keeping out sunlight in the Sports Hall.

Repairs to toilets – The necessary repairs were approved.

Fundraising Events – Rachel Hibbert talked about plans to hold a race night in the New Year to raise funds and also the Christmas party. Dates were still to be finalised.

Christmas Tree - It was agreed that a different option be considered similar to the tree erected near Vault Securities last year.

107/17 Football Ground

Funding Bid – Tony Trafford provided an update on the progress of the funding application to the Leader project. It was noted that the 20% contribution to the project would be found from lettings at the Football Ground/ Sports Hall, Sponsorship, and Fundraising events – a total of £11,200. Clive Fleetwood reported that he had contacted a number of business about sponsorship boards around the Ground. **It was agreed that a request be made to extend the deadline for completion and that the work to replace the MUGA was delayed until April after the football season had finished.**

Cricket Ground – The Council had received copies of emails from the Club sent to Glapwell Community Development Group about the use of the Ground for the bonfire on 4th November outlining conditions of use and suggesting that an alternative venue is found. They point out that the Ground is a Sports field. Members of the Development Group confirmed that they worked hard to

ensure that the playing surface was not affected at their events and that the cricket club did share the revenue from takings. **It was agreed that the Parish Council confirm the conditions in the license for the Cricket Ground includes the use of the Ground for community events and that this should continue.** It was noted that the cricket club had not paid the rent for 2017/18. The invoice was issued in June.
